

Princess Galyani Vadhana International Ensemble Competition 2023

1. GENERAL CONDITIONS

This is the tenth year of the Princess Galyani Vadhana International Ensemble Competition for the prestigious H.R.H. Princess Maha Chakri Sirindhorn's Trophy. With this annual competition we have developed a platform for young emerging musicians to encourage them to share their talents on an international stage, and to create opportunities for the public to appreciate their musical gifts.

The competition is open to musicians of all nations and will be conducted onsite at the Princess Galyani Vadhana Institute of Music.

2. AGE LIMITS AND CATEGORIES

- All performers must be born on or after January 1, 1996.
- First Prize winners of category B or C from previous years are not allowed to participate in the same category.

Category A: Large ensembles is suspended in 2023.

Category B: Chamber Ensemble (3 to 8 performers)

• Examples: Trio for violin, cello, and piano, String quartet, Quintet for guitar and strings, Sextet for winds or Saxophone quartet

Category C: Duo for Piano and another instrument OR Duo for Two Pianos

- Examples: Sonata for violin and piano, Sonata for clarinet and piano, Duo for harp and piano and Sonatas for two pianos.
- Concerto for solo instrument and orchestra accompanied by piano, and pieces for four hands on one piano are NOT allowed.

3. REPERTOIRE

Category B: Chamber Ensemble (3 to 8 performers)

Preliminary Judging

- The video recording should contain:
- 1. A piece or one movement of a piece from the Baroque, Classical, Romantic, or Modern period, composed and published between 1700 and 1970, selected from Repertoire Point 1 of the Competition Round.
- 2. A contrasting piece or a movement from a different period than Point 1, selected from Repertoire Point 2 of the Competition Round.

Competition Round

- No more than ten ensembles will be admitted.
- The performance should contain:
- 1. A complete work or movement(s) from the Baroque, Classical, Romantic, or Modern period, composed and published between 1700 and 1970. Duration: At least 6 minutes.
- 2. Another piece or movement(s) in a different period and style from Repertoire Point 1.
- The total performing time (including intervals between pieces) must amount to at least 15 minutes but must not exceed 25 minutes.
- Arrangements are allowed but published/printed score must be provided.
- Repeats are at the discretion of the competitors.
- Substitution of ensemble member(s) is not allowed.

Category C: Duo for Piano and another instrument OR Duo for Two Pianos

Preliminary Judging

- The recording should contain:
- 1. A piece or one movement of a piece from the Baroque, Classical, Romantic, or Modern period, composed and published between 1700 and 1970, selected from Repertoire Point 1 of the Competition Round.
- 2. A contrasting piece or a movement of a piece from a different period, selected from Repertoire Point 2 of the Competition Round.

Competition Round

- No more than ten duos will be admitted.
- The performance should contain:
- 1. A complete work or movement(s) from the Baroque, Classical, Romantic, or Modern period, composed and published between 1700 and 1970. Duration: At least 6 minutes.
- 2. Another piece or movement(s) in a different period and style from Repertoire Point 1.

- The total performing time (including intervals between pieces) must amount to at least 15 minutes but must not exceed 25 minutes.
- Original works are recommended. Arrangements with published score are allowed, self-arrangements are NOT allowed.
- Repeats are at the discretion of the competitors.
- The substitution of ensemble member(s) is not allowed.

4. PRIZES

Category B: Chamber Ensemble

 1^{st} Prize 100,000 THB 2^{nd} Prize 80,000 THB 3^{rd} Prize 60,000 THB

Category C: Duo for Piano and another Instrument OR Duo for Two Pianos

 1^{st} Prize 50,000 THB 2^{nd} Prize 40,000 THB 3^{rd} Prize 30,000 THB

Special Prize for both categories can be award according to the final judging.

- All participants of the Competition Round will receive a certificate of participation.
- The prizewinners are obliged, according to the wishes of the jury and the organizer, to participate in the Awards Ceremony and Prizewinners' Concert, otherwise they will lose their right to the prize awarded.
- Fees may not be claimed by any competitor, also not on account of television broadcasts or recordings made during the whole competition.

5. APPLICATION

- Applications can be made online until June 9, 2023, using the Online-Application on the homepage. www.pgvim.ac.th/pgviec
- The following documentation should be enclosed:
- 1) Application-Form: Please fill in the online-form completely in English
- 2) Video recording of the performance by the ensemble
- The applicants must provide a link to their video files such as YouTube, Vimeo or similar.
- The name of the ensemble, name of the recorded work, the precise duration and the date of the recordings must be visible on the video.
- The video must be recorded live in one take, without any additional technological manipulation, editing or processing and should be recorded in high quality.

3) Digital photograph of the ensemble

• Color, in good quality and high resolution. It will appear in the competition program.

4) Application-fee:

Category B: 80 US\$ (2,500 THB for Thai Applicants) per ensemble.

Category C: 60 US\$ (2,000 THB for Thai Applicants) per ensemble.

- The fee is non-refundable and must be remitted free of bank charges for the recipient.
- The receipt issued by the bank executing the transfer should be sent together with all other documents.

- All submitted application material cannot be returned.
- By submitting the application for the competition, the participant acknowledges the competition rules as well as the decision of the preliminary judging and the competition jury as binding. There is no right of appeal.
- Applications that do not meet the requirements of the competition will be rejected.
- All application material must arrive at the competition office by June 9, 2023. Uncompleted applications will be not considered.

6. PRELIMINARY JUDGING, ADMISSION

- A preliminary judging based on the video recordings will determine who may take part in the competition.
- The jury for the preliminary judging will consist of five members.
- By June 16, 2023 the results of the preliminary judging will be emailed to all applicants.
- The decisions are final and incontestable. No explanations will be provided.
- Together with the result of the preliminary judging, successful applicants will receive further information regarding the competition.

7. JURIES

- The juries were selected from among personalities with an international reputation, without regard to ethnic, ideological, political or linguistic considerations.
- The competitor's performance will be assessed with a points system.
- If a jury member has taught a competitor within the last two years, the jury person will not assess this competitor.
- The results are incontestable, and the jury's decision is final.
